

CITY OF FERNANDINA BEACH ADDENDUM NO. 3 ITB 19-05 AIRPORT OFFICE DEMOLITION AND HANGAR REHABILITATION


- 1. A site plan and original building plans are provided with this response. The City has no further documentation or building as-builts.
- Yes, temporary fencing is required with the purpose of containing debris from leaving the construction area and entering the active aircraft parking and movement area to meet the requirements of Federal Aviation Administration Advisory Circular (AC) 150/5370-2G "Operational Safety on Airports During Construction" as referenced within the scope of work for this bid invitation.
- 3. The City's electrician has confirmed that the electrical service for the hangar and office space enters the power utility closet from beneath the concrete slab of the office space. Contractor shall ensure that electrical power supporting hangar and apron lighting including gates are maintained as required.
- 4. No as-builts are available for the facility and the contractor is required to verify existence and facility components requiring relocation during its visual inspection of the facility which can be done during the pre-bid meeting or through subsequent site visits, which could be scheduled through the City.
- 5. No perc test has been completed. Please provide as detailed on the plans as this will meet existing soil conditions.
- 6. Please see gutter and downspout clarification sheet included with this response.
- 7. No as-builts are available. The contractor is required to complete visual inspection of the facility to determine mechanical/plumbing demolition requirements under this project.
- 8. During the pre-bid meeting, a question was asked as to how far back debris fencing could be placed from the building. This fencing can be placed approximately 50' from the building as depicted on the site plan at Exhibit 1, however the exact location and layout of this fencing will be determined in coordination between the Contractor and City prior to construction activity on the airport.
- 9. Toxic black mold is present within the office space to be demolished, and precautions should be taken to ensure that proper protection and disposal methods are used.
- 10. As shown on Image 1, the existing electric panel for apron lighting (including the control box) should remain. Please provide metal rack as required to mount existing equipment accordingly per NEC.
- 11. Contractor shall contact and coordinate with AT&T the removal of the existing telephone terminal and boxes shown on Image 1.
- 12. The existing double hose bibs shown on Image 2 should remain. Please provide a metal rack as required to mount and support existing piping including insulating the existing piping accordingly. Provide on primer coat and two top coats for metal racks.
- 13. Provide electrical wiring and conduit from existing apron lighting shown in Image 3, located at the SE exterior wall of the office space, to the electrical panel.


Exhibit 1 - Site Plan
























































