INSTRUCTIONS TO BIDDERS

Familiarity with Laws

The Bidder is required to be familiar with all Federal, State and Local laws, ordinances, rules and regulations that in any manner affect the work. Unfamiliarity or misinterpretation on the part of the Bidder will in no way relieve him from applicable responsibilities.

Bidding Documents

All of the descriptions of the work as well as of the instruments of procedure which are contained in Drawings and Specifications and including Addenda not contained therein comprise the Bidding Documents.

Addenda

In case the Architect finds it expedient to supplement, modify or interpret any portion of the Bidding Documents during the bidding period, such procedure will be accomplished by the issuance of written Addenda to the Bidding Documents which will be delivered electronically to all prospective Bidders.

Interpretation of Bidding Documents

No interpretation of the meaning of the Drawings, Specifications, or other Bidding Documents, no correction of any apparent ambiguity, inconsistency or error therein will be made to any Bidder orally.

<u>Every request for such interpretation or correction must be in writing, addressed to the Architect. All such interpretation and supplemental instructions will be in the form of written Addenda to the Bidding Documents. Only the interpretation or correction so given by the Architect, in writing, shall be binding and prospective Bidders are advised that no other source is authorized to give information concerning or to explain or interpret the Bidding Documents.</u>

Examination of Bidding Documents and Site Work

Bidders are required, before submitting their proposals, to visit the site of the proposed work and completely familiarize themselves with the nature and extent of the work and any local conditions that may in any manner affect the work to be performed and the equipment, materials, and labor required. They are also required to carefully examine the Drawings, Specifications and other Bidding Documents to inform themselves thoroughly regarding any and all conditions and requirements that may in any manner affect the work.

Preparation and Submission of Bids

Each Bidder shall copy the proposal form on his own letterhead indicating his prices thereon in proper spaces for the entire work and for alternates on which he bids. Any erasure or other correction in the proposal may be explained or noted over the signature of the Bidder. Proposals containing any conditions, omissions, unexplained erasures, alterations, items not called for or irregularities of any kind may be rejected by the Owner.

Receipt and Opening of Bids

Bids will be opened privately.

Bid Form Breakdown

A detailed bid form breakdown with detailed costs may be requested from the bidders for review. The breakdown format is included in the **Bid Form Breakdown** section of this Project Specification manual.



Rejection of Bids

The Owner reserves the right to reject any one or all bids, or any part of any bid, to waive any informality in any bid, and to award the purchase in the best interest of the Owner.

Award of Contract

The contract will be awarded as soon as possible to the lowest responsible Bidder provided his bid is reasonable and it is in the best interest of the Owner to accept it. The Owner reserves the right to waive any informality in bids received when such waiver is in the interest of the Owner.

Insurance

The Contractor shall maintain Builder's Risk Insurance sufficient to insure all the work through Final Completion. The Owner and Architect shall be named as "Additional Insured" on the policy. Evidence of insurance shall be submitted to the Owner within seven (7) days of Bid Award.

Supervision

The Contractor is required to provide full-time on-site supervision of the construction for the duration of the project. An acknowledgement of this intent is to be certified on the Bid Form.

Time of Completion

The Work to be performed under this contract is to be completed within <u>six (6) months</u> after completion of the signed Agreement for Construction, or receipt of construction permit, whichever is later.

Progress Payments

Based upon Applications for Payment submitted by the Contractor and Certificates for Payment issued the Owner shall make progress payments to the Contractor as provided in the Agreement. No payment will be allowed for any material or equipment stored off the project site without prior arrangement and written consent of the Owner.

Basis for Bidding, Trade Names, Performance Specifications

For clarity of description and as a standard of comparison, certain equipment, materials, etc., may have been specified by trade names or manufacturers to insure a uniform basis for bidding. The Bidder shall base his Proposal on the particular system, equipment or material specified. If there is a question about the approval of a manufacturer or product, call the Architect for verification. The Architect will entertain recommendations for alternate products or systems that will affect a savings to the Owner and are in the Owner's best interest.

Permits

The building permit may be submitted simultaneously with the bidding. If so, the permit will be updated with the Bidder's information, if necessary, upon award of a contract. Any changes within the Contract Documents that are not reflected in the permit documents will be submitted by the Architect to the Building Department to update the permit.

Governing Codes

The current Florida Building Code and Florida Fire Protection Code shall be followed for this project.



Design by Others

The existing fire suppression system requires modification. This work is to be provided by a Florida licensed fire system designer and installer. The cost for the design and installation is to be included in the bid price.

Checklist for Bid Submittal

The following items shall be included within the sealed bid envelope:

- A. Bid Proposal on Proposal Form
- B. Copy of current construction license issued in the state of Florida.

Each major item of work and each subcontracted item within each division shall be itemized. Lump sum amounts shall be broken down further if requested by the Architect.
